Speaking at the launch, Mr Kellee Kam, said that "SOGO-RHB Credit Card is targeted at discerning consumers looking to stretch their spending capacity. In understanding the needs of the "value seeker" market i.e customers who opt for better value for their money, we have positioned the SOGO-RHB Credit Card as a Double Rewards Card where customers get to earn cash back & S-Point."

Customers will earn 1 S-Point for every RM1 spent at KL SOGO Department Store and RM2 for KL SOGO Supermarket and places apart from KL SOGO when they swipe with their SOGO-RHB Credit Card. The total reward points accumulated will be reflected in KL SOGO S Card account on a monthly basis.

The credit card also offers holders up to 5% cash back for spending at KL SOGO. Cash back earned will be credited to customers' account monthly.

RHB Bank to date has a total of 2.3 million credit and debit cards in circulation, which totals to approximately 8% in credit card market share.
