## **GOLFING FOR CHARITY**

RHB distributes RM210,000 to charity from RHB Golf Classic 2015

**Kuala Lumpur, 7 September 2015** – The RHB Golf Classic 2015 held at the IOI Palm Garden Golf Resort, raised a total of RM210,000.
