RHB CELEBRATES HARI RAYA AIDIL ADHA WITH CHILDREN AT SELAYANG HOSPITAL

Kuala Lumpur, 23 September 2015 – On the eve of Hari Raya Aidil Adha, RHB Banking Group Managing Director, Dato' Khairussaleh Ramli together with the management of the Group, visited children at the paediatric wards of Selayang Hospital to celebrate the festival.

During the visit, patients from all three paediatric wards received *duit raya* and raya gift bags that consist of healthy food and beverage in addition to healthy lunch packs.

The Selayang Hospital's paediatric wards comprise a total of 160 beds. The hospital began offering paediatric rheumatology services in 2003 and has since been the only paediatric rheumatology tertiary referral unit in Malaysia. Founded by Dr Tang Swee Ping, Consultant Paediatrician and Paediatric Rheumatologist, the paediatric rheumatology unit offers specialised procedures for chronic conditions and life threatening cases for children with arthritis.

In addition, the unit also offers training to doctors and allied health professionals of the same field. It conducts research in paediatric rheumatology and the production of scientific papers.

With Dr Tang as the founding member and the current chairman of the Arthritis Foundation Malaysia (AFM) Junior Club, many paediatric patients from Selayang Hospital have benefited from its activities including day trips to Colmar Tropicale, Bukit Tinggi which were intended to introduce therapeutic horse riding. All activities organised by the AFM Junior Club are aimed at educating the children on their diseases and to empower them. Dr Tang established the AFM Junior Club to provide a patient support group for children and young people with arthritis.
